

Dear Beach Point Club Owner,

In order to provide a safe and enjoyable environment for everyone here at BPC, please fill out the enclosed pet registration with the required information and documentation community members will need to know of all pets on the property. Please fill out the enclosed Pet Registration form with the required information and documentation. Please include proof of pet's up to date vaccinations.

This information is required for two reasons...

- 1 To ensure that all eligible pets are registered with BPC before coming onto the property.
2. In case of an emergency, Board members, pet policy committee members, or emergency personnel will know that there is a pet living in your unit, and may assist in ensuring the pet's safety or take proper precautions needed when entering a unit.

It is imperative that all pet owners adhere to the rules and guidelines that have been agreed upon by all members. All pet owners on the property are required to register their pet(s) and may register up to two pets per owner and agree to take responsibility for the pet(s) that they register. Tenants may not have pets. "visiting" or unregistered pets will not be permitted on the property. A fine of up to \$100 per day will be imposed on a unit owner with an unregistered pet on the property, until the pet is removed.

- 1 Dogs must be on leash and under owner's control at all times when outside of their prospective unit.
- 2 Dog owners are required to immediately clean up waste after their dog.
- 3 Excessive noise or barking will not be tolerated and must be addressed by the owner immediately.
- 4 Any damage caused to common areas or other unit owners property caused by the pet is the responsibility of the person who registers that pet.
5. No pets are allowed in the pool area.

Any violations of the above rules will result in a fine of up to \$100, plus any damages. The board of trustees and/or members of the pet committee may require that the pet be removed if there are multiple violations and/or if they feel that the pet is a nuisance or danger to our community.
